The Malaysian Technical Cooperation Programme (MTCP) was officially launched on 7 September 1980 at the Commonwealth Heads of State Meeting in New Delhi, India, to signify Malaysia's commitment to the South-South Cooperation, in particular, the Technical Cooperation among Developing Countries (TCDC).

The MTCP emphasizes on the development of human resources through the provision of trainings in various areas which are essential for a country's development such as the public administration, good governance, health, education, agriculture, sustainable development, poverty alleviation, economy and finance, ICT and environment. Annually, Malaysia offered more than 65 capacity-building and technical assistance under the MTCP, which have benefited more than 34,000 participants from 144 countries.

WHO SHOULD APPLY

Application is open to officials from MTCP recipient countries who are 26 to 50 years old and had completed tertiary education, with at least five (5) years of work experience in tax administration.

Preference will be given to applicants with management responsibilities or exposure to administrative functions within a tax organisation. Applicants are required to have a good command of spoken and written English.

10 -15 participants will be selected based on regional representation. Each MTCP recipient country may nominate two (2) candidates although it is unlikely that more than one candidate per country will be considered for selection.

CLOSING DATE

The Application closing date is 15 April 2021.

Successful applicants will be notified by 15 May 2021 and pre- course information will be dispatched soon after.

Applicants are advised to furnish a facsimile (fax) number, valid e-mail address and their mobile number complete with country code in their application form to expedite communication.
