## **BRI Countries Project Description**

About the Organizer	Located at No. 66, Longzhu Street, Nanshan District, Shenzhen, the School of Administration of the State Administration for Market Regulation (SASAMR) is convenient in transportation. Seminar Content	Commissioned by Ministry of Commerce of PRC (MOF), the SASAMR will organize 2019 Seminar for Market Regulation and IPR Officials from BRI Countries 21 August 2019 to 9 September 2019 in China, with a duration of 20 days. The working language of this seminar is English. This seminar is intended to enhance market regulation and IPR officials' understanding of market regulation and IP development, basic situations, social development and related IP legal system of China, promote their communication of experiences in market regulation and IP legal protection with colleagues from China, broaden their horizons and increase their working ability. Closely related to the topic of market regulation and IP, this seminar will include lectures, tours and communication among students. In the lecture part, professors from universities will introduce basic situations of China, and director-general-level officials from the SAMR and director-level from the National Intellectual Property Administration (CNIPA) will give lectures on current IP protection in China, laws and regulations of market regulation, China's trademark legal system, China's patent legal system, business registration system reform, supervision of credits of market subjects, Internet market regulation. In the tour part, students will pay a visit to the Trademark Office of the CNIPA and Beijing SAMR Office, in which they will get a firsthand experience of trademark administration and protection as well as advertisement monitoring work in China. They will also pay a visit to sites of interest in Beijing and related enterprises and markets in Shenzhen, which will further promote students' understanding of China's market economy development. Through communication among students, they can

enhance the understanding and application of what is learned in the seminar. This seminar will have a positive influence on giving participating officials a comprehensive knowledge on China's market regulation and IP protection system and on promoting the communication and cooperation on market regulation and IP between China and BRI Countries.
