- 3) Overview of inspection and quarantine for China Customs: introduce the setup and duties, duties and laws and regulations of China Customs
- 4) China's entry and exit animal quarantine system: it introduces China's animal quarantine management system, and the cooperation between China and the World Organization for Animal Health (OIE).
- 5) China's entry and exit plant quarantine system: it introduces China's plant quarantine management system, import and export plant quarantine supervision procedures.
- 6) Approval of China's import and export plant quarantine and its practices: it introduces the main laws and regulations, technical standards of approval of China's import and export plant quarantine.
- 7) Quarantine approval of import and export animals and their products in China: it introduces the laws, regulations and technical standards on the quarantine approval of animals and their products imported and exported to China.
- 8) The OIE and its regulations: it introduces the main functions and main regulations of OIE.
- 9) Animal quarantine laboratory detection technology: it introduces animal epidemic disease laboratory detection technology.
- 10) Quarantine approval of animal-oriented food imported and exported to China: it introduces the laws, regulations and technical standards of animal-oriented food imported and exported to China.
- 11) Animal quarantine risk analysis: it introduces the diagnosis, prevention and control, monitoring of major animal epidemics, formulation of emergency plans, response to public opinion, etc.
- 12) Animal quarantine laboratory testing technology: it introduces the laboratory quarantine testing of animals and their products.
- 13) Food Safety Control in China: it introduces the laws, regulations and regulatory system of food safety for import and export in China.

<p>About the Organizer</p>	<p>Established in 2005, Jiangsu Inspection and Quarantine Institute of Quality (hereinafter referred to as JSIQ) is a public institution affiliated to Nanjing Customs with independent legal personality, and an organizer of the Chinese government's foreign aid training programs.</p> <p>JSIQ is a scientific research institute of quality integrated with quality research, international exchange, comprehensive training and management consultation; it now has seven major departments including the Department of Planning and Development, the Department of Quality Research and Consultation, the Department of International Communication and Cooperation, the Department of Domestic Training, the Department of Macro Quality Management, the Department of Technical Trade Measures, and the Department of Comprehensive Management; It also administers the Certification Consultation Center of CQC and China Entry-Exit Inspection and Quarantine Association Changzhou Branch. There are 40 staff in total.</p> <p>JSIQ has been undertaking the foreign aid training programs of the Chinese government since September 2006. It had undertaken 248 foreign aid training programs successfully as of December, 2022. JSIQ has trained 7478 officials and technicians from 148 developing countries and international organizations. The subjects of the training programs cover import & export commodity inspection, entry-exit animal and plant quarantine, entry-exit health and quarantine, import-export food safety, origin business of the Customs, trade facilitation of the Customs, standardization, metrology, certification and accreditation, market regulation, intellectual property right, etc. There are 9 working languages: English, French, Russian, Arabic, Spanish, Portuguese, Cambodian, Mongolian and Lao. Thus we have accumulated rich experience in foreign aid training in the field of customs and achieved fruitful results.</p>
