Objectives of the Training Course	<p>This seminar will invite the import and export commodity quality supervision officials of China Customs, quality inspection experts and professional and technical personnel to introduce the quality inspection and supervision of import and export commodities of China Customs, introduce the policies, measures and achievements of China Customs in cracking down on counterfeit and shoddy products in the international market, so that participants can understand the current situation of China's consumer goods manufacturing industry and reverse the negative perception of China's product quality. They will also understand the firm position and efforts of the Chinese government to safeguard the quality of export commodities and protect the legitimate rights and interests of consumers, and explore the international cooperation mechanism between China Customs and the Belt and Road countries to jointly combat counterfeit and shoddy products.</p>
