About the Organizer	Jiangsu Inspection and Quarantine Institute of Quality (hereinafter referred to as JSIQ established in 2005, is an independent legal entity affiliated to Nanjing Customs and the organizer of the Chinese government's foreign aid training programs.  JSIQ is a quality scientific research institution that integrates quality research, internation exchanges, comprehensive training, and management consulting. It currently has department usuch as the Planning and Development Department, the Quality Research Consulting Department, the International Exchange and Cooperation Department, the Domestic Training Department, and the Comprehensive Management Department. There are more than 40 form employees.  JSIQ began to undertake the Ministry of Commerce's human resources foreign aid training programs since September 2006. By December 2023, it had successfully organized 280 foreign aid training projects and trained 8,525 inspection and quarantine officials and profession technical personnelfrom 149 developing countries and international organizations on fit continents; the training contents cover import and export commodity inspection, entry and examinal and plant quarantine, frontier health quarantine, import and export food safety, custor origin management, customs trade facilitation, as well as standards, metrology, certification and accreditation, market regulation, intellectual property and other professional field programs are held in 9 languages: English, French, Russian, Arabic, Spanish, Portugues Cambodian, Mongolian and Lao. We have accumulated experience and achieved fruitf results in foreign aid training in the area of customs.		

- 1. The main presentations of this seminar include:
- (1) General Review of China: an introduction to China's political, economic, social, cultural and development status.
- (2) China's Reform and Opening up and the Belt and Road Initiative: an introduction to China's reform and opening up and the Belt and Road Initiative.
- (3) Overview of China Customs Inspection and Quarantine: an introduction to the structure, main functions, laws and regulations, international cooperation of China Customs.
- (4) China Customs Health and Quarantine System: it mainly introduces the history, institutional setup, laws and regulations of China Customs health and quarantine work.
- (5) Public Health Core Capacity Building at ports in China: This course focuses on the practice and effectiveness of public health core capacity building at ports in China against the background of port public health core capacity building as stipulated in the International Health Regulations (2005).
- (6) Health Supervision at POE: an introduction to the issue of health permit, routine health supervision at frontier ports, and key points of port health supervision during the COVID-19 epidemic.
- (7) China Customs Health Quarantine at Airports: it introduces the procedures ofhealth quarantine work of airport and aircraft.
- (8) China Customs Health Quarantine at Seaports: it mainly introduces the information declaration, risk assessment, quarantine mode judgment, on-board quarantine, sanitary treatment, certificate issuance, information reporting, etc.
- (9) China Customs Health Quarantine at Land Ports: it introduces the experience of Chinese Customs in scientific measures, precise prevention and control, comprehensively improving the health and security control capacity at land ports of border, and effectively building a health and quarantine defense line at ports.
- (10) Sanitary treatment and supervision at Chinese Ports: it introduces the sanitary treatment and supervision of Chinese Customs at frontier ports.
- (11) Medical Vector Surveillance at Ports in China: it mainly explains the significance and achievements of surveillance and control of ports and imported vectors in China, as well as strengthening international cooperation to prevent and control the spread of vector-borne diseases through international trade.
- (12) Study on the Prevention and Control System of Infectious Diseases at China's Frontier Ports: it introduces the management of entry-exit personnel and the prevention and control system of infectious diseases at China's frontier ports.
- 2. Trainees are organized to investigate the working site of China Customs, testing laboratories, and conduct symposium and discussion.
