Introduction of Training Contents	1, Introduction of Main Training Courses and Contents (1) General courses: 1) Introduction to National Conditions - Introduce China's basic political and economic systems, diplomatic concepts and development models, and enhance understanding of		

China's national conditions.

- 2) Prevention and control of COVID-19 - Introduce China's strategies for prevention and control of COVID-19 and international cooperation, and effective experiences in epidemic prevention and control.

(2) Professional courses:

- 1) Lectures on the diagnosis and treatment system of chronic diseases and the latest research progress in multiple fields, including:
- 2) Latest progress in the diagnosis and treatment of cardiovascular diseases;
- 3) Latest progress in the diagnosis and treatment of common and difficult respiratory diseases;
- 4) Latest progress in the diagnosis and treatment of chronic kidney disease;
- 5) Latest progress in the diagnosis and treatment of endocrine diseases;
- 6) Latest progress in diagnosis and treatment of rheumatic immune diseases; Latest progress in traditional Chinese medicine anti-epidemic thoughts and traditional Chinese medicine diagnosis and treatment of chronic diseases.

(3) Discussion and exchange of views:

- 1) Discussion on the concept and therapy of traditional medicine for tumor prevention and treatment: To discuss the prevention and treatment concept and treatment methods of traditional medicine in various countries represented by traditional Chinese medicine for the current high incidence of tumor diseases, and learn from each other.
- 2) Discussion on the establishment and patient management of Centers for Chronic Disease Control and Prevention: view exchange and explore effective national chronic disease control systems and patient management models on the current general trend of increasing chronic disease incidence in developing regions of the world.
- 3) Present Situation and Prospect of cardiovascular interventional therapy seminar: In view of the high incidence of cardiovascular disease, which is a serious threat to life, the seminar would arrange discussion on the use of cardiovascular intervention as a revolutionary treatment, especially the use of frontier interventional techniques such as communication of learning drug-eluting stents.
- 4) Present Situation and Future of Targeted Immunotherapy in Rheumatoid Arthritis (RA): Targeted immunotherapy is a hot topic in the field of RA treatment. The authoritative journals such as Nature and NEJM have published gratifying research results, thus the symposium and communication would be involved.

(4) Online visit:

To have a better understanding to the development status of China's pharmaceutical industry and promote industrial communication and cooperation between participated countries, it is planned to arrange an online visit to Wanbang Biopharmaceutical, a leading chronic disease drug R&D and production enterprise in China.

(5) Online culture experience:

In order to enable trainees to experience Chinese culture, it is planned to arrange an online experience of Chinese traditional tea art culture.

The average daily outpatient volume is about 10,000, with nearly 100,000 patients and nearly 40,000 surgeries per year.</p> <ol style="list-style-type: none"> 2) Peking University People's Hospital: a modern comprehensive tertiary hospital integrating medical treatment, teaching, scientific research and health care. It has 18 key clinical specialties of the National Health and Health Commission, 3 national multidisciplinary cooperative diagnosis and treatment capacity building projects for major diseases, and a total of 14 disciplines that are ranked among the top 20 in the China in terms of disciplinary influence. 3) Dongzhimen Hospital of Beijing University of Traditional Chinese Medicine: a large comprehensive tertiary hospital of traditional Chinese medicine, which integrates medical treatment, teaching and scientific research. It is a national clinical research base of traditional Chinese medicine, a national drug clinical trial institution identified by the National Food and Drug Administration, and a training base for TCM appropriate technology projects of the World Health Organization. 4) Zhongshan Hospital of Shanghai Fudan University: Diagnosis and treatment of heart, liver, kidney and lung diseases are the focus and characteristics of the hospital. The hospital has a national intractable disease diagnosis and treatment ability improvement project (cardiovascular and cerebrovascular direction), a national key discipline (respiratory) development project. 5) China-Japan Friendship Hospital, the First Affiliated Hospital of Guangzhou Medical University and other well-known tertiary hospitals in China <p>3, Materials for trainees to prepare</p> <p>Trainees need to prepare relevant information to participate in the discussion according to the theme of the communication activities.
