Seminar Content **Project background:** In order to thoroughly implement President Xi Jinping's important instructions on "strengthening global taxation cooperation" and "helping developing countries and low-income countries to improve taxation collection and management capacity", we will give full play to the positive role of the Belt and Road tax collection and management cooperation mechanism in building a win-win international tax system, continue to promote the construction of the Belt and Road tax collection and management capacity, strive to create a growth friendly tax environment, enhance the position and role of Chinese taxation in global taxation governance, build a more indepth, comprehensive and diversified Belt and Road taxation cooperation. The State Administration of Taxation plans to hold a multilateral taxation seminar for the Belt and Road countries, provide taxation training and strengthen taxation exchanges, so as to effectively help the Belt and Road countries improve tax collection and management capabilities, establish multilateral friendly cooperation, promote regional cooperation and win-win situation, and do a good job in serving national diplomatic strategies.

Training purpose: This seminar aims to promote the exchange and cooperation between China and the Belt and Road countries in the field of taxation, improve their taxation administration

capacity, enhance mutual trust in interconnection, lay a solid foundation for negotiating and signing taxation agreements between China and relevant countries, promote the development of intraregional economic and trade relations, create a good international environment for more enterprises to "go out", gain the trust and support of more developing countries, enhance China's status and discourse in the field of international taxation.

Training content: The seminar will focus on "certainty of taxation". The lecture includes: overview of China's national situation, China's reform and opening up and the path to Chinese modernization, global development initiatives, a community with a shared future for mankind and China's taxation system, international double taxation, mechanisms to eliminate double taxation, basic theory of taxation dispute and transfer pricing, international trends of tax dispute resolution, domestic tax dispute resolution and practice, cross-border tax dispute resolution practice cases, research on the dispute settlement mechanism of the Belt and Road initiative, etc.

Training method: We sincerely invite Chinese taxation experts to give lectures according to the topics; organize exchanges between participants and experts, as well as between participants; during the study tour in Beijing and Yangzhou, the officials will also visit local taxation authorities and large enterprises, and communicate with Chinese taxation officials and enterprise representatives.

- 4. After picking up the luggage, please wait patiently at the international arrival exit (or domestic arrival exit) and the organizer will pick you up with a pick-up board with your name on it. If waiting for more than 15 minutes, you can communicate with the organizer by phone.
- 5. In case of lost baggage so you need to register the loss procedure with the airline, please first communicate with the organizer to confirm the baggage delivery location and then fill
