Seminar Content	<p><b>Project background:</b> Currently, the digital wave is sweeping the world. With the development of digital economy, society, families, and even people are in the informational, digital, networking and intelligent era. President Xi Jinping emphasized at the 2nd session of Belt and Road International Cooperation Summit that "innovation is productivity, which is the foundation for strong enterprises and prosperous countries. We should follow the development trend of the fourth industrial revolution, jointly grasp the opportunities of digitalization, networking and intelligence, jointly explore new technologies, new industries and new models, find new growth and development paths, build the digital and innovative silk road." At present, more and more countries recognize the important role of cloud computing, big data, cyber security for digital economic transformation and national governance capacity. However, countries and regions along the Belt and Road are mostly in the early stage of digital transformation, which are facing common threats such as: network information security, high frequency of cyber security incidents. Due to the limitations of their own</p>	

	<p>conditions, many countries have insufficient technology, funds and resources in cyber security and cloud computing, so they need to carry out exchange and cooperation in developing cyberspace and cloud computing.</p> <p><b>Training purpose:</b> This seminar aims to strengthen the experience exchange in digital technology and management of "new infrastructure" between China and the "Belt and Road" countries, to promote the competent ministries and senior managers in information technology to gain new knowledge in the digital transformation of cloud computing, cyberspace security, to understand the cutting-edge technologies and management models in the digital transformation of China's economy, and promote cooperation between China and relevant countries in the field of "digital new infrastructure".</p> <p><b>Training content:</b> The seminar will mainly focus on the overview of China's national conditions, China's reform and opening up and the path to Chinese modernization, global development initiatives, a community with a shared future for mankind, Chinese leaders' philosophy of governing the country, common values between China and the world, the prospect of new technologies for economic digital transformation, the development trend of cybersecurity threats and risk management caused by new technologies, the ideas and methods of building a new cyber security digital system, introduction to key capabilities of cloud computing technology, the development of China's e-government informatization construction, development trend of zero trust industry, the integration of data elements and data security construction, the historical review of network information attack and defense war, etc.</p> <p><b>Training method:</b> We sincerely invite experts in China's digital new infrastructure technology and related fields to give lectures for the officials according to the topic; organize exchanges between participants and experts, as well as between participants; organize field visits to digital new infrastructure technology enterprises in Beijing and other cities. (The above is a preliminary schedule, which may be adjusted based on the actual situation. The final version will be provided after your arrival in China.)</p>
Notes	<ol style="list-style-type: none"> <li>1. Please prepare your passport, Chinese visa and third-party transit country visa (if necessary) before coming to China.</li> <li>2. If participants cannot depart on time due to special circumstances, or if there is a flight delay during the transfer, please contact the Economic and Trade Office or the organizer in time, inform the latest flight No. and time of arrival in Beijing so that we can arrange pick-up for you.</li> <li>3. In principle, it is not allowed for individuals to change their tickets to China. If you really need to do so, please contact the Business Office and follow the procedures to change your ticket.
