(7) China's Development and Status Quo of Social Security System: to introduce the current status of China's social security institutional development, alongside its system and major functions.

(8) China's Public Administration Departments and Institutions for Social Policy: to introduce the public departments and systems that handle social welfare in China.

(9) China's Demographic Trends and Response to Aging Society: to introduce China's demographic trends, its population policies, and responses to aging society.

(10) China's Demographic Statistics and Policy Applications: to introduce the methods, techniques and applications of demographic statistics in China and its implications in public policy making.

(11) China's Labor Supply and Economic Development: to offer an introduction on supply and quality of China's labor force, alongside its role in economic development.

(12) China's Development of Social Work: to introduce the development and practices of social work in China.

(13) China's Social Policy and Social Governance: to introduce the methods for formulation, implementation and assessment of social policies in China, as well as successful experience in social governance.

(14) China's Social Welfare: to introduce the development trajectory of social welfare in China as well as the management and operation of social welfare institutions.

(15) China's Poverty Reduction and Social Security in Rural Areas: to introduce the creation and development of social security system and efforts on poverty reduction in rural areas of China.

(16) Belt and Road Initiative and International Cooperation: to introduce the main contents, values and practices of the Initiative proposed by China, as well as international cooperation thereof.
