Content

019 Seminar for Financial Cooperation Between Developing Countries is sponsored by the Ministry of Commerce of People's Republic of China and undertaken by Renmin University of China (RUC). The seminar has arranged classical courses, presentations, inspections and visits for officials of developing countries.

The Seminar lasts for 21 days, and 14 lectures will be delivered, covering basic, core, professional together with exploratory courses. Basic courses include: Fundamental Realities of China, Review of China's Economic Opening, China's Development of Foreign Trade, Development and Prospect of China's Investment in Foreign Countries. Core courses: Development of China's Financial System, Management of China's Foreign Exchange, Management of Banks in China, Studies on Experience and Situation of how China Attracts FDI. Professional courses: China's Concessional Loan Business, Construction of China's Free Trade Area and Financial Opening, Introduction of New Multilateral Development Organizations and the Silk Road Fund, China's Business Work and Foreign Aid. Exploratory: Appreciation of Traditional Chinese Culture, Policies and Practices of Foreign Trade and Investment in Local Governments, etc.

All the lectures echo with the core of the seminar and are internally correlated. The lectures, from different perspectives, introducing the foundation, potential, mode and prospect of China's financial cooperation with other countries, covering both theoretical and practical knowledge, macroscopically and microscopically.

Apart from the lectures, exchange of national conditions amongst different countries will be held twice, which targets at making officials better understand their own country's economic development status and foreign trade situation. Chances to communicate with RUC students will also be provided so as to initiate mutual understanding.
