This information relates to a JICA Knowledge Co-Creation Program with a focus on groups and regions, conducted by the Japan International Cooperation Agency (JICA). This program is implemented as part of the Official Development Assistance provided by the Government of Japan, based on a bilateral agreement between both governments.

#### JICA Knowledge Co-Creation Program (KCCP)

The Japanese Cabinet released the Development Cooperation Charter in June 2023, which stated, "In its development cooperation, Japan has maintained the spirit of jointly creating things that suit partner countries while respecting ownership, intentions and intrinsic characteristics of the country concerned based on a field-oriented approach through dialogue and collaboration. It has also maintained the approach of building reciprocal relationships with developing countries in which both sides learn from each other and grow and develop together." JICA believes that this 'Knowledge Co-Creation Program' will serve as a foundation of mutual learning process.

# I. Concept

#### 1. General Contour of the Program:

This training course aims to analyze the issues related to local governance in participating countries, with a specific focus on comparing Japan with other participating nations. By identifying and understanding the challenges faced by local governments in different contexts, this course will provide insights and recommendations for improving local governance systems.

#### 2. Background of the Program:

Local governance plays a vital role in shaping and maintaining effective public administration within a country. However, various challenges can hinder the efficiency and effectiveness of local governments, thereby impacting their ability to deliver quality services to citizens. This training program focuses on comparing the problems encountered in local governance in Japan and other participating countries, with the aim of identifying similarities, differences, and potential solutions.

#### 3. Overall Course Content:

The program will begin by identifying common issues prevalent in local governance across participating countries. These may include but are not limited to: lack of transparency, bureaucratic inefficiencies, limited citizen participation, inadequate resource allocation, and challenges in policy implementation. The course will delve into the specific problems encountered in Japan's local governance system and compare them with those in other participating countries.

#### 4. Outcomes of the Program:

The training course will provide a comprehensive overview of the challenges faced in local governance, highlighting both similarities and differences between Japan and other participating countries. By examining the unique contexts of each nation, this program will hopefully be able to identify underlying causes and systemic factors contributing to these issues.

#### 5. Assessment Report: Past and Future:

The participants in this training program are assigned the responsibility of elucidating particular policy issues within the local entities of Japan that have made a lasting impact on them. This task is outlined in the document titled "The Assessment Report: Past and Future."

The paper aims to explore the feasibility of integrating some of the policies you have observed in Japan into the policy framework of your local government.

Angola, Bangladesh, Kyrgyz, Timor-Leste, Trinidad and Tobago, Uganda, Ukraine, and Viet Nam

#### 4. Eligible / Target Organization:

This program is designed for both central government offices (the Ministry of Interior, etc.) and local public organizations responsible for local administration.

#### 5. Course Capacity:

8 participants

#### 6. Language to be used in this program:

#### 7. Course Objective:

Participants will develop an "Assessment Report: Past and Future" for the feasibility of integrating some of the policies you have observed in Japan into the policy framework of your local government.

#### 8. Overall Goal:

Each participant will finalize a five- or ten-year-plan which will be implemented for improving the local governance in their country.

#### 9. Tentative Schedule of the Program:

This program consists of the following components. Details on each component are given below:

#### Stage 1 (Preparatory Phase of the Program) = April 2024.

The participants of this program is expected to prepare and submit "Inception Report" to JICA. Each participant will be requested to deliver one's report at the outset of the course in Japan.

The participants will receive various lectures on different topics of significance of local government and governance. Likewise, they will visit a number of local governments or facilities to experience actual operations of Japan's local units of government.

As you can see in the tentative schedule above, each participant will make a presentation based on his/her inception report. These presentations give the participants the opportunity to compare the local government system among participating countries. When presenting, it is desirable to use PowerPoint slides.

# III. Eligibility and Procedures

#### 1. Expectations from the Participating Organizations:

- (1) This program is designed primarily for organizations that intend to address specific issues or problems identified in their operation. Participating organizations are expected to use the program for those specific purposes.
- (2) This program is enriched with contents and facilitation schemes specially developed in collaboration with relevant prominent organizations in Japan. These special features enable the program to meet specific requirements of applying organizations and effectively facilitate them toward solutions for the issues and problems.
- (3) As this program is designed to facilitate organizations to come up with concrete solutions for their issues, participating organizations are expected to make due preparation before dispatching their participants to Japan by carrying out the activities of the Preparatory Phase described in section II-9.
- (4) Gender Equality and Women's Empowerment: Women are encouraged to apply for the program. JICA is committed to promoting gender equality and women's empowerment, and provides equal opportunities for all applicants regardless of their sexual orientation or gender identity while selection shall be made according to the qualifications mentioned in 2.of each nominee.

#### 2. Nominee Qualifications:

Applying Organizations are expected to select nominees who meet the following qualifications.

#### **Essential Qualifications**

- 1) Current Duties: <u>be civil service personnel of central or local government</u> <u>engaged in local administration</u> and be promising candidate for future management positions.
- 2) Experience in the relevant field: <u>have more than 5 years' experience in local administration.</u>
- 3) Educational Background: be a graduate of university.
- 4) Language: <a href="https://example.com/have a competent command of spoken and written English">have a competent command of spoken and written English</a> which is equal to TOEFL CBT 250 or more. (This seminar includes active participation in discussions, perspective report development, thus requires high competence of English ability. Please attach an official certificate for English ability such as TOEFL, TOEIC etc, if possible).
- 5) Age: be aged between 25 to 40 in principle.
- 6) Those who have participated in the similar program(s) sponsored by JICA or other Japanese organizations are disqualified.

7) Health: must be in good health to participate in the program in Japan. To reduce the risk of worsening symptoms associated with respiratory tract infection, please be honest to declare in the Medical History (QUESTIONNAIRE ON MEDICAL STATUS RESTRICTION of the application form) if you have been a patient of following illnesses; Hypertension / Diabetes / Cardiovascular illness / Heart failure / Chronic respiratory illness.

#### 3. Required Documents for Application

- (1) Application Form: The Application Form is available at the JICA office (or the Embassy of Japan).
  - \* If you have any difficulties/disabilities which require assistance, please specify necessary assistances in the QUESTIONNAIRE ON MEDICAL STATUS (1-(c)) of the application forms. It may allow us (people concerned in this course) to prepare better logistics or alternatives.
- (2) Photocopy of passport: to be submitted with the application form, if you possess your passport. If not, you are requested to submit its photocopy as soon as you obtain it.
  - \*Photocopy should include the followings:

Name, Date of birth, Nationality, Sex, Passport number and Expire date.

- (3) Nominee's English Score Sheet: to be submitted with the Application Form. If you have any official documentation of English ability (e.g., TOEFL, TOEIC, IELTS), please attach it (or a copy) to the application form.
- (4) Inception Report: to be submitted with the Application Form.

It will be used for selection of participants. The instructions of the Inception Report are shown in VI. ANNEX 1 "Outline of Inception Report" for the details. You should submit also a presentation material (desirably PowerPoint slides) of the Inception Report for group discussion by the beginning of the course in Japan.

**(5) Questionnaire (Purpose of participation):** to be submitted with the application form. Please use the form, VII. ANNEX 2.

#### 4. Procedures for Application and Selection:

(1) Submission of the Application Documents:

Closing date for applications: Please inquire to the JICA office (or the Embassy of Japan).

(After receiving applications, the JICA office (or the Embassy of Japan) will send them to **JICA Tokyo Center in JAPAN** by March 25, 2024).

#### (2) Selection:

Primary screening is conducted at the JICA overseas office (or the embassy of Japan) after receiving the documents through proper channels from your government, the JICA office (or the embassy of Japan) will conduct screenings, and then forward the documents to the JICA Center in Japan. Selection will be made by the JICA Center, in consultation with the Local Autonomy College (LAC) in Japan. The applying organization with the best intention to utilize the

opportunity of this program will be highly valued in the selection.

The Government of Japan will examine applicants who belong to the military or other military-related organizations and/or who are enlisted in the military, taking into consideration of their duties, positions in the organization and other relevant information in a comprehensive manner to be consistent with the Development Cooperation Charter of Japan.

#### (3) Notice of Acceptance

Notification of results will be made by the JICA office (or the Embassy of Japan) not **later than April 19**, **2024**.

#### 5. Conditions for Attendance:

The participants of KCCP are required.

- (1) to strictly observe the course schedule,
- (2) not to change the air ticket (and flight class and flight schedule arranged by JICA) and lodging by the participants themselves,
- (3) to understand that leaving Japan during the course period (to return to home country, etc.) is not allowed (except for programs longer than one year),
- (4) not to bring or invite any family members (except for programs longer than one year),
- (5) to carry out such instructions and abide by such conditions as may be stipulated by both the nominating Government and the Japanese Government in respect of the course,
- **(6)** to observe the rules and regulations of the program implementing partners to provide the program or establishments,
- (7) not to engage in political activities, or any form of employment for profit,
- (8) to discontinue the program, should the participants violate the Japanese laws or JICA's regulations, or the participants commit illegal or immoral conduct, or get critical illness or serious injury and be considered unable to continue the course. The participants shall be responsible for paying any cost for treatment of the said health conditions except for the medical care stipulated in (3) of "5. Expenses", "IV. Administrative Arrangements",
- (9) to return the total amount or a part of the expenditure for the KCCP depending on the severity of such violation, should the participants violate the laws and ordinances,
- (10) not to drive a car or motorbike, regardless of an international driving license possessed,
- (11) to observe the rules and regulations at the place of the participants' accommodation, and
- (12) to refund allowances or other benefits paid by JICA in the case of a change in schedule.

# LOCAL GOVERNANCE in Global Perspectives (JFY 2024)

# Outline of Inception Report

All applicants for this program are required to submit "Inception Report" on one of the issues elaborated below to identify the problems which you are facing. The Committee of Experts of this program will select the participants based on your report. Therefore, the report must be submitted with the Application Form. The paper should be in English. It ought to be type written in double-space and in an A4 size paper. The length is approximately 6 pages.

#### The Report should include:

- 1. Name of the Course
- 2. Name of Applicant and Country
- 3. Major Theme of Your Report

The primary theme of this program is about local government and related policy. The program is centered on such prominent issues as decentralization, local governance and local human capacity building. Of many problems and issues, an applicant ought to choose ONE ISSUE and formulate the report along this single problem. The applicant is encouraged to elaborate on the issue in his/her own experience. Those reports which would only enumerate several issues without analytical comments would be screened out and considered disqualified.

#### 4. The Organization which you belong to

(1) What is the issue?

Taking the thematic contour of program into account, you are first asked <u>clearly to</u> <u>identify the most important issue that your local governments have lately</u> been facing.

\* Please take up only one issue which you think is the most important. Please DO NOT take up more than one issue.

(2) Why is the issue so critical?

You are likewise requested to elucidate and elaborate on the reason for the problem. Your report ought to provide a deep analysis and statistical data to substantiate your opinion.

- (3) How has your government been dealing with the problem?

  You are also requested to describe your policy efforts to alleviate the effects of the critical issue.
- (4) What is your future program to combat the issue?
  You must write a future policy to deal with the problem.

Development of Union Councils by Own Financial Resources Mobilization

### 4. The Organization which you belong to (1) What is the issue? Union Councils being the century old rural local government are yet to fulfill the expectations of rural citizen which is mainly due to own resources constrains including miserable local resources mobilization. (2) Why is the issue so critical? Since the independence, many projects have been taken for rural development. But still 40% of the population lives under the poverty line. It is perceived that there were weak revenue administration, inadequate adjustments and assignments of local revenue

(3) How has your government been dealing with the program?

sources, absence of effective tax assessment system.

The government has recognized the Union Councils as a primary economic and administrative unit of rural local government and has undertaken initiatives to streamline the local revenue administration and resources mobilization.

In 2009, first 174 Union Councils and then 264 Union Councils in LIC areas received predictable formula-based direct block grants, for FY 2008-2009 and 2009-2010 respectively to accomplish necessary development for their constituents.

#### (4) What is your future program to combat the issue?

The Union Councils will implement activities aimed at identifying potential areas of resource mobilization, such as public-private partnerships, outsourcing and improved management and collection of current or new fees, taxes and licenses. In parallel, the campaign program will be conducted to ....

#### For Your Reference

#### **JICA and Capacity Development**

Technical cooperation is people-to-people cooperation that supports partner countries in enhancing their comprehensive capacities to address development challenges by their own efforts. Instead of applying Japanese technology per se to partner countries, JICA's technical cooperation provides solutions that best fit their needs by working with people living there. In the process, consideration is given to factors such as their regional characteristics, historical background, and languages. JICA does not limit its technical cooperation to human resources development; it offers multi-tiered assistance that also involves organizational strengthening, policy formulation, and institution building.

Implementation methods of JICA's technical cooperation can be divided into two approaches. One is overseas cooperation by dispatching experts and volunteers in various development sectors to partner countries; the other is domestic cooperation by inviting participants from developing countries to Japan. The latter method is the Knowledge Co-Creation Program, formerly called Training Program, and it is one of the core programs carried out in Japan. By inviting officials from partner countries and with cooperation from domestic partners, the Knowledge Co-Creation Program provides technical knowledge and practical solutions for development issues in participating countries.

The Knowledge Co-Creation Program (Group & Region Focus) has long occupied an important place in JICA operations. About 400 pre-organized course cover a wide range of professional fields, ranging from education, health, infrastructure, energy, trade and finance, to agriculture, rural development, gender mainstreaming, and environmental protection. A variety of programs is being customized by the different target organizations to address the specific needs, such as policy-making organizations, service provision organizations, as well as research and academic institutions. Some programs are organized to target a certain group of countries with similar developmental challenges.

#### **Japanese Development Experience**

Japan, as the first non-Western nation to become a developed country, built itself into a country that is free, peaceful, prosperous and democratic while preserving its tradition. Japan will serve as one of the best examples for our partner countries to follow in their own development.

From engineering technology to production management methods, most of the know-how that has enabled Japan to become what it is today has emanated from a process of adoption and adaptation, of course, has been accompanied by countless failures and errors behind the success stories.

Through Japan's progressive adaptation and application of systems, methods and

technologies from the West in a way that is suited to its own circumstances, Japan has developed a storehouse of knowledge not found elsewhere from unique systems of organization, administration and personnel management to such social systems as the livelihood improvement approach and governmental organization. It is not easy to apply such experiences to other countries where the circumstances differ, but the experiences can provide ideas and clues useful when devising measures to solve problems.

JICA, therefore, would like to invite as many leaders of partner countries as possible to come and visit us, to mingle with the Japanese people, and witness the advantages as well as the disadvantages of Japanese systems, so that integration of their findings might help them reach their developmental objectives.
